

Shane's Rib Shack Holiday "Wait & Win" Promotion Official Rules No Purchase or Payment Necessary to Enter or Win. A Purchase Will Not Increase Your Chances of Winning

**1. Eligibility:** This Shane's Rib Shack "Wait & Win" Promotion ("Promotion") is open to legal residents of the 50 United States and Washington, D.C. who are 18 years of age or older as of 12/1/16. Employees of Shane's Rib Shack ("Sponsor") and its affiliates, subsidiaries, advertising and promotion agencies and suppliers that are involved in this Promotion (collectively, the "Promotion Participants"), and each of their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, and half-sister) and/or those living in the same household of each are not eligible. Void where prohibited by law.

**2. How it Works:** Beginning on 12/1/16 and ending on 12/31/16 or when supplies of Promotion game envelopes are exhausted, an eligible person visiting a participating store (listed below) will receive one (1) envelope ("Game Envelope") with an enclosed (i) instant win message ("Menu Prize"), and (ii) unique game code ("Game Code"), upon purchase of a qualifying menu item (any Sandwich Combo, Plate, Tenders or Wings Meal). Alternatively, to receive a free Game Envelope without making an eligible purchase, send a self-addressed, stamped (#10) envelope to: Shane's Rib Shack "Wait & Win" Game Envelope Request: 829 Fairways Court Ste 200, Stockbridge, GA 30281, postmarked by 12/31/16 and received by 1/4/17 (while supplies last) (Vermont residents may omit postage); Limit one (1) Game Envelope per person, per store visit, per day (regardless of method of receipt), or per mailing envelope.

Customers must present and redeem their unopened Game Envelope at the Shane's Rib Shack location where they received it (unless received by mail) between 1/1/17 and 2/28/17 ("Redemption Period") to reveal their prize and enter the Grand Prize Promotion Drawing. Each Game Envelope will include one (1) Menu Prize that must be redeemed upon opening the Prize Envelope (Exception: "Free Catering for 25 People" Prize may be redeemed at a later date, see Section 5 for details; Game Code must still be entered during Redemption Period to enter into the Grand Prize Promotion Drawing). To receive an entry ("Entry") into the Grand Prize Promotion Drawing, participant will follow the redemption instructions provided at the Shane's Rib Shack location and submit the unique Game Code together with the requested information concerning participant (first name, last name, & phone number) via the sanctioned Entry device at such location. Participants must present their Game Code(s) at the Shane's Rib Shack location where they received such code(s) during the Redemption Period. Participants that receive a Game Envelope by mail may present such unopened Game Envelope at any participating location during the Redemption Period. Each Game Envelope will entitle an eligible participant to one (1) entry into the Grand Prize Promotion Drawing.

NOTE: Florida residents must present their unopened Game Envelope at participating Florida Shane's Rib Shack locations ONLY to be eligible for all prizes listed under Section 5.

**3. Grand Prize Promotion Drawing:** Following the end of the Redemption Period, Sponsor, or its designated agent (PlumReward), will select winners by random drawing from among all eligible Entries during the Redemption Period on or about March 3, 2017 ("Grand Prize Promotion Drawing"). Grand Prize Promotion Drawing will be conducted by Sponsor, or its designated agent (PlumReward), as determined in its sole discretion. Exactly one (1) Grand Prize Winner (the "Grand Prize Winner"), one (1) Second Prize Winner ("Second Prize Winner"), one (1) Third Prize Winner ("Third Prize Winner"), and five (5) Fourth Prize Winners ("Fourth Prize Winner" or collectively "Fourth Prize Winners") will be selected from all eligible Entries received from ALL Regions (e.g., Region One, Region Two, Region Three, and Region Four as defined below). For the avoidance of doubt, the "Grand Prizes Drawing" (as used in the promotion materials or otherwise) will be deemed to mean the Grand Prize Promotion Drawing for all purposes.

**4. Verification:** All prize claims are subject to verification. In the event of a printing, production or other error or irregular Game Envelopes & Game Codes, neither the Sponsor nor the Promotion Participants shall have any liability beyond reasonable efforts to award the advertised number of prizes specified in these official rules. Game Envelopes that are not obtained through authorized, legitimate channels or that are forged, altered, blank in whole or in part, reproduced, tampered with in any way, mutilated, incomplete or that contain printing, production, typographical, mechanical, or other errors are automatically void. Titles, taxes, registration and insurance fees are responsibility of Grand Prize Winner.
